This signed Authority and Mandate refers to my Rally Attendance Application dated _____ ("the Agreement") which I acknowledge will be for a 9-month period only.


I/We hereby authorise you to issue and deliver payment instructions to your Banker for collection against my/our above-mentioned account at my/our above-mentioned Bank (or any other Bank or branch to which I/we may transfer my/our account) on condition that the sum of such payment instructions will never exceed my/our obligations as agreed to in the Agreement commencing on _____ and continuing for 9 months.

The individual payment instructions so authorised to be issued must be issued and delivered as follows: monthly.

In the event that the payment day falls on a Sunday, or recognised South African public holiday, the payment day will automatically be the very next ordinary business day. Furthermore, if there are insufficient funds in my account to meet the obligation, you are entitled to track my account and re-present the instruction for payment as soon as sufficient funds are available in my account.

Payment instructions due in December may be debited against my account on _____

I/We understand that the withdrawals hereby authorised will be processed through a computerised system provided by the South African Banks. I also understand that details of each withdrawal will be printed on my Bank statement. Such must contain a number, which must be included in the said payment instruction and if provided to me should enable me to identify the Agreement. This number must be added to this form in Section E before the issuing of any payment instruction.



B. Mandate

I/We acknowledge that all payment instructions issued by you shall be treated by my/our above-mentioned Bank as if the instructions have been issued by me/us personally.

Debit orders run for a full 9 months upon inception of this signed Debit Order. If the Debit order is cancelled for any reason the outstanding amount due must be paid in full immediately.

C. Cancellation

I/We agree that this Authority and Mandate cannot be cancelled within a 9-month cycle as my H.O.G.® Rally Fees are paid in advance on my behalf. Thereafter notice of cancellation must be given at least 1 (one) month prior to the termination of a 9-month cycle in order to terminate this debit order Authority and Mandate as it takes one month to be removed from the cycle.

D. Assignment

I/We acknowledge that this Authority may be ceded or assigned to a third party if the Agreement is also ceded or assigned to that third party, but in the absence of such assignment of the Agreement, this Authority and Mandate cannot be assigned to any third party.
